## LAYAWAY CONTRACT

Flyrite Choppers is happy to accommodate parts, frame and chassis orders through our layaway plan. For your convenience, we offer 30, 60 and 90-day layaway plans to U.S. customers. You choose the plan that is most convenient for you. There are no service charges for our layaway plan.

Follow the ordering steps below. Please contact us anytime, with questions or concerns. Thank you for your business!

### TERMS AND CONDITIONS

- Orders of \$300.00 or more (not including shipping).
- 25% deposit is required for all layaway purchases and is non-refundable and non-transferable.
- Payment methods accepted for layaway purchases: Visa or Master Card (we will manually charge your credit card according to the payment plan you choose below.); PayPal (we will issue you a PayPal invoice.); Cashiers Check/Money Order (payments via mail must be received by the due date and in accordance to the payment plan, chosen below).
- Payments must be made regularly, as scheduled, and must be received by us, on or before the day they are due.
- Monthly payments will be due the same day your order was submitted to us, until paid in full. (e.g.: order submitted on July 1st; payments will be due each month on the 1st).
- Bi-weekly payments will be due every 14 days until paid in full. (e.g.: order submitted on June 4th; First payment will be due on June 18th, and so forth).
- If you have trouble making a payment please contact us immediately (before your payment is due). We would be glad to discuss options with you.
- In the event of default or cancellation, Layaway payments will be issued as store credit only. Deposit will not be refunded or issued as store credit. No cash refunds.
- Order will be canceled after 90 days, if not paid in full.
- Due to the nature of our items, we will not process your order until the final payment has cleared. Please allow 10 business days (for parts only orders), or 2-4 weeks (for frame/roller/brake orders) from the date your final payment has cleared, for your order to be processed and shipped to you.

### ORDERING STEPS

1. Layaway orders may be made by telephone only - (512) 918-2467.
2. Initial payment (deposit) will be 25% of your total order (not including shipping).
3. Layaway contract will be provided to you by e-mail, fax, or mail as desired.
4. Please complete this Layaway Contract and return by mail, scan/e-mail or fax.

### DEFINITIONS

- Bi-weekly: payment made every 14 days (every two weeks).
- Monthly: payment made once a month.
- Deposit: down payment; a partial payment made at the time of purchase; the balance to be paid later.
- Default: failure to complete a scheduled payment (missed payment due date).
